

**MEDICAL (SETTING OF EXAMINATION  
FOR PROVISIONAL REGISTRATION)  
REGULATIONS 1993\***

IN exercise of the powers conferred by section 36 of the Medical Act 1971, the Malaysian Medical Council, with the approval of the Minister, makes the following regulations:

**1. Citation.**

These regulations may be cited as the **Medical (Setting of Examination for Provisional Registration) Regulations 1993.**

**2. Application.**

Subject to regulation 13 these Regulations shall apply to a person who holds a qualification referred to in subparagraph 12(1)(a)(ii) of the Act.

**3. Interpretation.**

In these Regulations-

“examination” means any final year examination set or to be set an examining body;

“examination” means any higher educational institution which is a body approved by the Minister under paragraph 12(1)(aa) of the Act;

“higher educational institution” means any Faculty or School of Medicine of any University Colleges Act 1971.

**4. Application to sit for examination.\***

An application to sit for the examination of an examining body shall be submitted to the Council in duplicate in Form 1 of the Schedule, and must reach the Council at least three months before the first day of the proposed examination of the examining body which first sets the examination, together with the fee of two hundred ringgit.

**5. Assignment of examination.**

(1) The Council shall assign among the candidates, by means of a ballot, the higher educational institution at which a candidate is to sit for the examination:

Provided that a candidate who has failed an earlier examination shall be assigned the examination set by the same examining body which set the earlier examination.

- (2) The assignment of a higher educational institution in sub regulation
- (1) shall be final.

**6. Candidate subject to rules of examining body.**

Each candidate shall be subject to the rules of the examining body which sets the examination the examination including the resitting of any examining and the imposition of any fee.

**7. Candidate not allowed to sit for examining body which sets the examining body.**

- (1) Where a candidate who-
  - (a) has failed an examination at his first try; or
  - (b) resits for an examination for any number of times as may be allowed by the same examining body which had set the examination,

is disallowed, for whatever reason, from sitting for any further examination by the same examining body he shall not subsequently make a similar application to sit for an examination set by any other examining body.

- (2) A candidate who, acting in contravention of subregulation (1), sits for an passes an examination shall not to be issued the certificate under regulation 12.

**8. Maximum number of candidates.**

- (1) The maximum number of candidates for an examination set by the following examining body shall be-
  - (a) fifty of University Kebangsaan Malaysia;
  - (b) twenty for University of Malaya; and
  - (c) thirty for Universiti Sains Malaysia.

- (2) Priority shall be given to a candidate who has previously failed an examination.

**9. Date of examination.**

- (1) The date of a proposed examination shall be published in at least one local newspaper at least four months before the first day of the examination of the examining body which first sets the examination.
- (2) The examining body may, if necessary, cancel a proposed examination or defer its date.

**10. Withdrawal from examination.**

If a candidate withdraws or is absent from the examination, the fee paid under regulation 4 shall not be refunded unless the withdrawal or absence is due to medical reasons

**11. Communication of result.**

The Council shall communicate to each candidate the result of the examination as far as it pertains to him.

**12. Issue of certificate.**

Subject to subregulation 7(2) the Council shall issue a certificate in FORM 2 of the Schedule to a candidate who passed the examination.

**13. Revocation and savings.**

(1) The Medical (Setting of Qualifying Examinations) Regulations 1977 is revoked.

(2) Notwithstanding subregulation (1) the operation of these Regulations shall not apply to a person who immediately before the coming into force of these Regulations-

(a) holds a qualification referred to in subparagraph 12(1)(a)(ii) of the Act; and

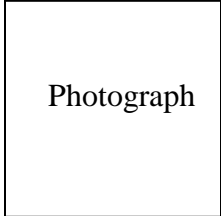
(b) has made an application to sit, resit or had sat for the examination set under the revoked Regulations,

and the revoked Regulation shall continue to apply to such person as if it had not been revoked.
