



**MALAYSIAN MEDICAL COUNCIL
GUIDELINES FOR APPLICATION
CERTIFICATE OF GOOD STANDING**

1. Certificate of Good Standing (COGS) shall be issued to all practitioners who are registered with the Malaysian Medical Council.
2. Certificate of Good Standing shall be issued to all practitioners who not have disciplinary action taken or pending against them.
3. Certificate of Good Standing will not be issued for personal use by the Registered Medical Practitioner.
4. Certificate of Good Standing from MMC cannot be used for registration purposes with MMC.
5. Foreign Medical Councils / Professional Licensing Bodies will require the COGS to be sent directly to them. MMC will not be liable for COGS which is rejected by Foreign Medical Councils / Professional Licensing Bodies due to submission personally by the practitioner.
6. COGS Fee Schedule:

Services	Fee (RM)
Application for Certificate of Good Standing	RM500
Application for a copy of COGS	RM200
Delivery of documents by post	RM20

7. All applications will be processed within five (5) working days.
8. The COGS will be sent by ordinary mail. Practitioner may make the necessary arrangements for delivery by courier services.
9. The Certificate of Good Standing is only **valid for three months (3)** from the date of issue.
