The following documents need to be submitted by *foreign medical practitioners* already registered with the MMC applying for removal of conditions and restrictions from their Full Registration Certificate.

1. A formal letter of application including the Application Form for Removal of Conditions & Restrictions in Full Registration Certificate. (Original + 1 copy)
2. Certified true copy of Permanent Resident Identity Card. (2 copies)
3. Confirmation letter of Permanent Resident Status or Nationality from *Jabatan Pendaftaran Negara*. (Original + 1 copy)
4. Compulsory Service Exemption Request Form. (Original)

5. Certified true copy of applicant's "Service Book" from Ministry of Health or Public Institution. (1 copy)
6. A Statutory Declaration - Should your printed name(s) in any of the submitted document(s) differ (stating the name as on the identity card is the same individual). (Original)
7. A RM500.00 fee in bank draft, money order, postal order or banker's cheque form in favour of '*Kumpulan Wang Majlis Perubatan Malaysia*'.
