PEMILIHAN AHLI MAJLIS PERUBATAN MALAYSIA

Sukacita dimaklumkan bahawa suatu sesi penamaan calon telah diadakan sepanjang bulan Januari dan Februari 2020 untuk mengisi satu (1) kekosongan jawatan dalam Majlis Perubatan Malaysia di bawah Seksyen 3A(1)(f) Akta Perubatan 1971 bagi mewakili negeri Sabah.

Hanya seorang Pengamal Perubatan Berdaftar yang bermastautin di negeri Sabah telah dicalonkan untuk mengisi satu (1) kekosongan jawatan tersebut. Calon tersebut adalah:

1. **Dr. Hjh. Suzain Bt. Datuk Hj. Suhaimi**

Memandangkan hanya seorang calon dinamakan dan tiada bantahan dibuat di atas pencalonan tersebut, **Dr. Hjh. Suzain Bt. Datuk Hj. Suhaimi** telah berjaya tanpa bertanding mengikut Subperaturan 10 Peraturan-peraturan Perubatan 2017.
