KEKOSONGAN DAN PEMILIHAN AHLI MAJLIS PERUBATAN MALAYSIA

DIBAWAH SEKSYEN 3A(1)(E) AKTA PERUBATAN 1971 (PINDAAN 2012)

Sukacita dimaklumkan, terdapat enam (6) kekosongan jawatan dalam Majlis Perubatan Malaysia dibawah Sekysen 3A(1)(e) Akta Perubatan 1971 (Pindaan 2012) bagi mewakili negeri-negeri di Semenanjung Malaysia. Berdasarkan Peraturan Peraturan 2017, dibawah Akta tersebut, satu pemilihan untuk mengisi kekosongan tersebut akan diadakan pada **Januari 2021**.
