Kindly note the following:

- i. Malaysians who are Registered Medical Practitioners (RMP's) having a 2022 APC up till 30 April 2022 (based on the Council's records), and lists any state in Peninsular Malaysia as their main place of practice, will be eligible to vote.
- ii. Ballot papers will be sent by **registered post** to eligible voters starting after the third week of May 2022 to the main place of practice listed in their APC's.
- iii. Voters should expect to receive their ballot papers latest by 31<sup>st</sup> May 2022.
- iv. Those who have not received their ballot papers after this date may request for a new ballot paper to be sent to them, after submitting a **statutory declaration**, through email at [election@mmc.gov.my](mailto:election@mmc.gov.my). Please refer to the voting guidelines for details.
- v. However, many practitioners only list their employer/institution as the main place of practice in their APC's without further details of their Departments or Clinics. As such, before applying for a new ballot paper, voters should first check with the administrative office of their respective employer/institution.
- vi. Voters may also request new ballot papers if it has been lost or damaged. Requests should again be included with a **statutory declaration**.
- vii. Voters should vote for **not more than 9 candidates** to avoid disqualification. Please refer to the voting guidelines for details.
- viii. Completed ballot papers should then be sent back to the Returning Officer using the self-addressed envelopes supplied in the manner prescribed in the voting guidelines.
- ix. Voters may also **send in their votes by hand** at the Malaysian Medical Council, 1<sup>st</sup> Floor, Block C, Ministry of Health Malaysia, Jalan Cenderasari, 50590 Kuala Lumpur.
- x. Ballot papers should reach the MMC **not later than 4.00 p.m. on 22 July 2022**.
- xi. All voters are reminded to send in their votes as early as possible to avoid disqualification.
- xii. Vote counting will be held at the offices of the Malaysian Medical Council, Ministry of Health Malaysia, Jalan Cenderasari, 50590 Kuala Lumpur on **23 July 2022**.
