

## **PEMAKLUMAN PEMBAHARUAN TANDATANGAN PENDAFTAR PENGAMAL PERUBATAN MAJLIS PERUBATAN MALAYSIA**

Seperti yang sedia maklum, YBhg Datuk Dr.Muhammad Radzi Bin Abu Hassan telah dilantik sebagai Ketua Pengarah Kesihatan yang baharu merangkup Presiden Majlis Perubatan Malaysia berkuatkuasa 21 April 2023. Sehubungan itu, semua sijil pendaftaran yang dimuat turun melalui sistem MeRITS akan mengalami perubahan tandatangan selaras dengan fungsi beliau sebagai Pendaftar Pengamal Perubatan.

Oleh yang demikian, Majlis Perubatan Malaysia (MPM) akan membuat proses pertukaran tandatangan Pendaftar tersebut di dalam sistem MeRITS. Selaras dengan perkara ini, Majlis Perubatan Malaysia (MPM) akan memberi laluan kepada semua Pengamal Perubatan bagi memuat turun sijil pendaftaran dengan tandatangan **mantan Presiden MPM yang telah diluluskan** sebelum 21 April 2023 bagi tempoh satu (1) minggu mulai **17 Mei 2023** sehingga **23 Mei 2023**.

Selepas tempoh tersebut, pengamal perubatan yang terlibat tidak akan dapat mengakses sijil pendaftaran mereka melalui sistem MeRITS namun sebarang permohonan "soft copy" dengan tandatangan mantan Presiden boleh dipohon secara emel daripada pihak sekretariat.

### **NOTICE OF REGISTRAR'S SIGNATURE CHANGES IN MALAYSIAN MEDICAL COUNCIL**

Please be informed YBhg Datuk Dr.Muhammad Radzi Bin Abu Hassan has been appointed as the new Director General of Health as well as President Malaysian Medical Council. With the appointment, all registration certificate downloaded from the MeRITS system will have a change of signature with regards to this change of function as registrar of Medical Practitioner.

To this effect, Malaysian Medical Council is currently undergoing process of changing the signature. Therefore, MMC will give a grace period of one (1) week to all registered practitioner from 17<sup>th</sup> May 2023 until 23<sup>rd</sup> May 2023 to download any certificate that was previously approved with the signature of previous MMC President dated before 21<sup>st</sup> April 2023.

Subsequently, after the stipulated time given, should there be any necessity to request for the softcopy version of certificate by the previous President, it can be requested manually by emailing the secretariat.
