The **background of the candidates** can be accessed from the MMC's website mmc.gov.my.

Kindly note the following:

- i. Malaysians who are Registered Medical Practitioners (RMP's) having a **2023 APC up till 30th September 2023** (based on MMC's records), and lists any state in **Peninsular Malaysia** as their main place of practice, will be eligible to vote.
- ii. Ballot papers will be sent by **registered post** to eligible voters starting from the **first week of November 2023** to the main place of practice listed in their APCs.
- iii. Voters should expect to receive their ballot papers latest by **10th November 2023**.
- iv. Those who have not received their ballot papers after this date may request for a new ballot paper to be sent to them starting on **1st December 2023**, after submitting a **statutory declaration**, through email at election@mmc.gov.my. Please refer to the voting guidelines for details.
- v. However, many practitioners only list their employer/institution as the main place of practice in their APCs without further details of their Departments or Clinics. As such, before applying for a new ballot paper, voters should first check with the administrative office of their respective employer/institution.
- vi. Voters may also request new ballot papers if it has been lost or damaged. Requests should again be included with a **statutory declaration**.
- vii. Voters should vote for **not more than 6 candidates** to avoid from being disqualified. Please refer to the **voting guidelines** attached with the ballot paper.
- viii. Completed ballot papers should then be sent back to the Returning Officer using the self-addressed envelopes supplied in the manner prescribed in the voting guidelines.
- ix. Voters may also **send in their votes by hand** at the Malaysian Medical Council, Block C, 1st Floor (Counter), Jalan Cenderasari, 50590 Kuala Lumpur.
- x. All voters are reminded to send in their votes as early as possible to avoid from being disqualified.
- xi. Ballot papers should reach the Malaysian Medical Council **not later than 4.00 p.m. on 22nd December 2023**.
- xii. Vote counting will be held at the Malaysian Medical Council, Block C, Jalan Cenderasari, 50590 Kuala Lumpur on **23rd December 2023**.
