# GUIDELINE FOR CANDIDATES SITTING THE EXAMINATION FOR PROVISIONAL REGISTRATION (EPR) (THEORY) VIA ONLINE PLATFORM

# (All candidates must read, understand, and adhere to this guideline)


- 1. The Examination for Provisional Registration will be conducted fully via an online through the Examplify application by ExamSoft.
- 2. Before starting the examination, you must comply with the minimum system requirements for the device you will be using. (At this moment, only Mac, Windows and iPad systems are supported).
- 3. You are required to have a functioning **built-in camera** and **built-in microphone** ready in your device for the examinations.
- 4. EXTERNAL headphones or earphones are **NOT** allowed during the examinations.
- 5. It is important to note that once Examplify has been installed, you must use the same device when taking your examination.
- 6. Kindly ensure that you have a stable and good internet connection throughout the examinations (For purposes of logging in to Examplify, uploading of answers and recordings)
- 7. The examination will be conducted in a secure environment and will be equipped with ExamID and ExamMonitor, whereby you will be recorded and monitored throughout your examination.
- 8. There will be two (02) papers consisting of Medical and Surgical based papers. You are required to sit for both papers and submit them accordingly when you have completed the examination within the stipulated time.
- 9. Kindly take note of the date and timing of your examinations. The duration of each paper is 90 minutes, with a 30-minute break in between papers.
- 10. You will be notified via email about 24 hours before the examination starts to download the relevant examination questions.
- 11. You will be given an access password via email that was registered with ExamSoft, 10 minutes before the examination begins.
- 12. Once you have entered the password, **PLEASE DO NOT NAVIGATE BACKWARD**, as this will block you from sitting the examination.
- 13. During the examination, Examplify application will secure your device and close any other open applications. You will only have access to the Examplify application.
- 14. You are not allowed to view any external devices (e.g., mobile phone) or view any other unauthorized materials.
- 15. You are reminded to avoid any suspicious movements as you are being recorded and monitored.
- 16. Please be reminded that you will not be allowed to leave your device or leave the camera's view when the examination is in progress.
- 17. Your recordings will be reviewed. If there is any suspicion of misconduct, the Malaysian Medical Council reserves the right to take any action necessary, including disqualifying you for the examinations. If you are being disqualified, that will be considered as one (01) attempt.
- 18. It is crucial for you to watch the video listed at the end of these guidelines.

# Registering on ExamSoft

- 1. Before registering, you will receive an email from ExamSoft.
- 2. If you are a returning user, you may use your existing ExamSoft ID to complete the registration (if you have received or registered to sit for EPR with the MMC previously).
- 3. Upon successful registration and login, you will need to download and install Examplify.
- 4. Upon successful downloading and launching of Examplify, you will need to agree to the software license agreement.
- 5. Then, you will be prompted to choose the Institution ID, which is Malaysian Medical Council or MMCMY.
- 6. You are required to sign in using the email address which you have registered.

# **Downloading the examination questions**

- 1. You will be receiving another notification via email to download the examination questions. It will be available to download about 24 to 2 hours before the examination begins. The examination questions will appear on the left side of the panel.
- 2. Kindly make sure that you are downloading the correct examination questions.
- 3. Please ensure that ExamID and ExamMonitor icons are visible under the exam settings as shown below:



### Sitting for the examination

1. On the day of the examination, you should have already downloaded the examination questions.

- 2. You are required to enter the password to access the examination questions that will be given to you via your registered email about 10 minutes before the examination begins.
- 3. After the password is entered, you will be prompted to the next step to take a baseline photograph which will be captured in real-time.
- 4. Kindly ensure that you are seated in a well-lighted area and your face is clearly visible.
- 5. Kindly follow the instructions and PLEASE DO NOT NAVIGATE BACKWARD.
- 6. You will be directed to the next page to start your examination.
- 7. Kindly make sure to answer all the questions and click on the correct area. If the question has been answered, a small blue tick will appear at the right end of the answer.

# Submitting the examination

- 1. Once you have completed the examination, please make sure that you submit it and wait for it to be completely uploaded.
- 2. Once uploaded, you may go back to the dashboard and that completes the examination process.
