



**MALAYSIAN MEDICAL COUNCIL  
GUIDELINES FOR APPLICATION  
CERTIFICATE OF GOOD STANDING**

1. Certificate of Good Standing (COGS) shall be issued to all practitioners who are registered with Malaysian Medical Council.
2. You will be eligible for a Certificate of Good Standing (COGS) **ONLY** if you fulfill **ALL** of the following conditions:
  - 2.1 You are registered with MMC;
  - 2.2 Your name is still borne in the Malaysian Medical Register (section 11 of the Act);
  - 2.3 There is **NO** disciplinary action pending against you under the **Act**;
  - 2.4 There is **NO** disciplinary action taken against you under the **Act**; **AND**
  - 2.5 You have **NOT** committed any offence against **the Act**;
3. The Council will **NOT** process any COGS if it is:
  - 3.1 For personal use; or
  - 3.2 For application to register with MMC; or
  - 3.3 For practice in Malaysia
4. To apply for COGS you should:
  - 4.1 complete the **application through MeRITS online application portal**
  - 4.2 complete **all fields**;
  - 4.3 and submit supporting documents if applicable
5. You are strongly advised to respond immediately **through MeRITS** to our notification for any queried application, if any.
6. **The application will only be processed within Seven (7) working days after receiving the complete application.**
7. Foreign Medical Councils / Professional Licensing Bodies will require the COGS to be sent directly to them. MMC will not be liable for COGS which is rejected by Foreign Medical Councils / Professional Licensing Bodies due to submission personally by the practitioner. Please state clearly the address(es) where it should be posted. You will be notified by email once it is sent.
8. If you want it to be sent through express mail or courier service; please liaise directly with the courier agency for collection. Please take note that the courier fees are under your expenses.

9. COGS Fee Schedule:

| <b>Services</b>   | <b>Fee (RM)</b> |
|---|-----------------|
| Application for Certificate of Good Standing                | RM500           |
| Application for a copy of COGS                              | RM200           |
| Delivery of documents by MMC courier service – Pos Malaysia | RM20            |

10. The Certificate of Good Standing is only **valid for three months (3)** from the date of issue. You are strongly advised to ensure WHEN you need the COGS and to submit your application accordingly.

11. Please **contact us** if you;

- a. Do not hear from us fourteen working days after the application was submitted ;
- b. Do not hear from us after processing period is over; and/or
- c. Require any assistance or have any questions.
