

MALAYSIAN MEDICAL COUNCIL GUIDELINE FOR EXTENSION OF PROVISIONAL REGISTRATION

- The validity period of the Provisional Registration Certificate is three (3) years after the date of issuance of the Provisional Registration Certificate.
- 2. Provisionally registered medical practitioners who are unable to be eligible for full registration within the three (3) years <u>may apply for an extension</u> of the provisional registration.
- Applicants are responsible to ensure that they possess a valid license to practice at all times and are responsible for submitting the extension applications.
- 4. Each application for extension shall be for *not more than* one (1) year.

Extension process

- All applications shall be made to the Malaysian Medical Council in the specified application form. The application form must be accompanied by the following supporting documents:
 - i. proof that shows the applicant has been offered a new appointment / contract renewal / contract extension to practice as a houseman in a hospital/medical institution approved by the Medical Qualifying Committee under Section 13 of the Medical Act 1971; AND
 - ii. a formal letter justifying the extension (stating the reasons for such application);AND
 - iii. If the applicant has health problems, a medical report from a relevant medical practitioner is required.
- 2. You may be required to submit additional information/documents to help the Council decide whether you are suitable to be given an extension of the provisional registration.

3. A RM100.00 fee in the form of an electronic payment method such as credit/debit card or online banking/transfer shall be made to the Malaysian Medical Council. All online banking/transfer shall be made to our beneficiary account. Please submit the proof of payment in your application.
