1.	Form 12 – Specialist Registration Application Form with Passport Photograph	
2.	A current curriculum vitae that includes: <ul style="list-style-type: none"> - Summary of hospitals/institutions worked in with duration; - Summary and evidence of training received, and competencies attained including the duration; - Professional work experience (clinical, research and/or academic, where applicable) including the duration; - Continuing Professional Development activities or updating of skills including the duration. (indent as one of the stems) 	
3.	A certified true copy of the basic medical degree	
4.	A certified true copy of the specialist qualification(s)	
5.	A certified true copy of proof of specialist registration in the country of training or practice (if applicable)	
6.	A certified true copy of proof of completion of specialist training (e.g. CCT, official letter)	
7.	A certified true copy of a letter of proof of employment as a specialist and/or a testimonial from the current or last employer (if applicable)	
8.	A certified true copy of the offer letter for employment as specialist in Sarawak	
9.	A current and original Letter of Good Standing/Certificate of Good Standing/Professional Standing from the medical regulatory/licensing authority in the country where the applicant last practiced	
10.	All applicants with qualification(s) obtained outside Malaysia will need to undergo primary source verification of the specialist qualification(s). This may be by the Educational Commission for Foreign Medical Graduates (ECFMG), Dataflow, or any other organization approved by the Council. The onus is on the applicants to approach these organizations to undertake primary source verification at their own expense and for these organizations to send the relevant report(s) directly to the Council.	
11.	A Logbook (verified by Supervisor/Head of department)	
12.	Details of specialist training structure (with curriculum if applicable) in chronological order, including the following details: <ul style="list-style-type: none"> - Unit/ Department/ Name of Training Center - Country of the Training Center - Name of Supervisor - Supervisor's Email - Period(s) of Training 	
13.	Two Referees' reports (submitted directly by referees to the MMC)	
14.	Supporting documents on International/Academic Recognitions: <ul style="list-style-type: none"> - Publications; - Awards; - Academic appointments; or - Others 	
15.	Proof of Payment of Registration fee	
16.	Fitness to Practice Declaration Form and supporting documents	

17.	A statutory declaration, where applicable (If the name in the documents is different from the identification card)
