



NOTIS PEMBERITAHUAN

KEKOSONGAN DAN LANTIKAN AHLI MAJLIS PERUBATAN MALAYSIA

DI BAWAH SEKSYEN 3A(1)(c) AKTA PERUBATAN 1971

Sukacita dimaklumkan, terdapat tiga (3) kekosongan jawatan dalam Majlis Perubatan Malaysia (MPM) di bawah Seksyen 3A(1)(c) Akta Perubatan 1971 bagi mewakili **Sektor Swasta** di seluruh negeri di Malaysia. Berdasarkan Akta Perubatan 1971, di bawah Akta tersebut, tiga (3) orang pengamal perubatan yang berdaftar penuh daripada sektor swasta adalah layak untuk dinamakan oleh Majlis dan dilantik oleh YB Menteri Kesihatan.

Bagi tujuan tersebut **calon** hanyalah dari Pengamal Perubatan Berdaftar **warganegara Malaysia** yang mempunyai Perakuan Amalan Tahunan semasa (PAT 2026) yang sah permohonannya dengan alamat tempat amalan utama di **sektor swasta**.

Manakala, **pencadang** dan **penyokong** hendaklah merupakan Pengamal Perubatan Berdaftar **warganegara Malaysia** yang juga mempunyai Perakuan Amalan Tahunan (**PAT 2026**) semasa yang sah dengan alamat tempat amalan utama di **sektor swasta**.

APPOINTED FOR THE VACANCY IN THE MALAYSIAN MEDICAL COUNCIL

UNDER SECTION 3A(1)(c) OF THE MEDICAL ACT 1971

It is hereby announced that there will be vacancies in Malaysian Medical Council (MMC) for three (3) elected members to represent **Private Sector** under Section 3A(1)(c) of the Medical Act 1971. In accordance with the Medical Act 1971 enacted under the said Act, three (3) fully registered medical practitioners from the private sector are eligible to be nominated by the Council and appointed by the Minister of Health.

For this purpose, all fully Registered Medical Practitioners who are **Malaysian citizens** possessing an Annual Practising Certificate (**APC 2026**) stating their principal address of practice in the **Private Sector** are eligible to be **nominated** to fill these vacancies.

The nominees shall be **proposed** and **seconded** by fully Registered Medical Practitioners who are also Malaysian citizens possessing a current Annual Practising Certificate (**APC 2026**) stating their principal address of practice in the **Private Sector**.
