Please be reminded that, **ONLY Malaysians who are Registered Medical Practitioners having an Annual Practising Certificate (APC) year 2026 up until 30 September 2026** (based on the MMC records), listing **Peninsular Malaysia** as their main place of practice, will be **eligible to vote**. Practitioners are advised to list their employer/institution with details of their departments or clinics as the main place of practice in their APC.
